#### **Position Overview**

As a Program Associate you will play a critical role in the execution of the Equitable Industrial Development Initiative (EqID) to accelerate employee-ownership in the industrial business sector in New York City. Reporting to the Director of Industrial Business Development, the program associate will identify and assist businesses to adopt employee-ownership models. You will play a multi-faceted hands-on role to support businesses and work on the cutting edge of community economic development in New York City. In partnership with the Mayor's Fund to Advance New York City, the Mayor's Office of Minority-and Women-owned Business Enterprises, Citi Community Development and The Working World, the initiative seeks to engage and support industrial businesses in learning about and adopting employee-ownership. As a community economic development organization, BOC Network supports local industrial and manufacturing businesses in New York City to start, operate and grow by connecting businesses with resources, capital, and incentives.

This position offers the unique opportunity of immersion in a business training curriculum to learn about the fundamentals of worker-ownership conversions led by an experienced cooperative developer, the Working World, and the opportunity to work on pioneering ideas in community development financing to drive impact. After gaining knowledge by working on real-time conversions, the program associate will conduct outreach and build a pipeline of potential employee-ownership conversions. The role will focus on innovative finance, equitable economic development as well as operations, strategy-setting and execution. The work will be fast-paced, diverse, and will overlap with multiple community economic development projects simultaneously. The successful candidate will need to blend flexibility with disciplined execution in their work approach in order to manage competing demands and deliver high quality work.

You are the right fit for this role if you have a passion for the intersection between finance and social impact, an entrepreneurial spirit, strategic mindset, and ability to work efficiently in a fast-moving environment. The ideal candidate will also bring excellent interpersonal abilities complemented with strong analytic skills, judgment, and practical sense that translates to supporting small businesses.
