# About the Job

#### Asset Manager

This junior-level management position plays a key role in the ongoing oversight and performance of CLOTH's multi-family portfolio while performing a wide variety of tasks including preparing and analyzing property and portfolio reports. Employee will be responsible for oversight of CLOTH properties and Property Manager; CLOTH employs a Third Party Manager that is responsible for managing the buildings, supervising maintenance personnel, collecting rent, monthly reports and compliance.

## **Essential Duties**

- Work with senior staff, third-party asset management and third-party property management companies overseeing the operations of the portfolio to maximize operating results and increase value of the assets
- Review and analyze monthly, quarterly, and annual financial reports to monitor results and identify issues and trends
- Develop action plans to correct issues for watchlist properties and other underperforming assets
- Participate in the review of annual property operating budgets
- Review property documents to highlight ongoing reporting and compliance requirements and work with internal and external parties to ensure compliance
- Perform regular site visits to existing properties to assess operations
- Complete special projects and analyses as needed
- Responsible for all GP reports to Syndicators; HPD, HUD and other organizations or agencies
- Review and approve such items as budgets, purchases above a predetermined level
